  - By Physical Delivery. Deliver your comments/question by delivering them to the Utility Bill Drop Box at City Hall no later than 5:00 pm on Monday, June 8, 2020.
- 2) Live Comment During Meeting Via Telephone. Residents desiring to make public comments by telephone during the public hearing must request to be placed on the public hearing agenda. You may do so by calling City Hall 320-286-5505 or emailing [bpotter@cokato.mn.us](mailto:bpotter@cokato.mn.us) You must provide your name and telephone number and request to be placed on the agenda no later than 5:00 pm on Monday, June 8, 2020. Each resident will be given a maximum of 3 minutes to make his/her comment.
